

APPLICATION for ELECTION to MEMBERSHIP:

1. I/We hereby apply for membership to the Browns Bay Boating Club Inc (BBBC) including Tractor User status for Applicant 1 and Applicant 2 as applicable. I/We will abide by all of the rules of the Club and by lawful directions of the BBBC Committee or Committee members.. Where the application is for Tractor User status, the Boat Safety Check and Driver training is to be completed and passed prior to being submitted to the Committee. The Subscription due is to be paid or submitted with the Application.
2. On completion of the Boat Safety Check and Tractor Training a Tractor Key and Tractor Shed access Card will be allocated. The Tractor Key and access card remain the property of the BBBC and are allocated to the member for their sole use. On withdrawal from the BBBC, the Key and Card shall be returned to a BBBC Committee member without delay.
3. The Club Committee shall, at the next Committee meeting, consider each application and shall vote thereon. A majority of those present shall be required to elect an applicant to Membership. Until the decision of the Committee is known the applicant may be considered to be a Probationary Member.
4. When the Membership is confirmed you will be advised and a Membership Card provided.
5. **SKIPPER RESPONSIBILITY – I/We acknowledge that the Skipper of my/our boat is responsible for the safe operation of my/our vessel and the safety and wellbeing of all passengers and crew. Furthermore the Skipper is also responsible for ensuring all relevant regulations and maritime rules are adhered to.**
6. This form collects personal information about you. The information will be collected and stored by BBBC in accordance with the Privacy Act 1993. The information will be used in relation to the administration of your membership. We will communicate with you about Club matters and events by mail and/or email. Your information will not be provided to external parties for promotion or advertising purposes. A Safety Inspection is carried out when the applicant first seeks membership and every 3 years following. Note:

The Safety Inspector may reject any vessel or item of equipment considered unsound or unsafe. In the event of a dispute the owner may appeal to the Commodore who will appoint 2 people who together with the Safety Officer will re-inspect the vessel. Their decision will be final.

SAFETY CHECK REQUIREMENTS

- NAME.** On both sides of the boat legible from 30 metres. 90mm minimum letter height.
 - ANCHOR.** Of suitable type and weight for the boat.
 - ANCHOR CHAIN.** Minimum of one boat length of suitable size (up to 8M 6 mm, 8-14M 9mm).
 - ANCHOR WARP.** Up to 5M 8mm, 5-8M 10mm; 8-14M 12mm
 - LIFEJACKETS.** Must be standard mark. Must be one life jacket per person in the boat at all times.
 - FIRE EXTINGUISHER.** To be either CO2 or Dry Powder
 - SOUND SIGNAL**(whistle, trumpet, horn etc) Not dependent on engine or battery.
 - FIRST AID KIT.** (Approved safety standard)
 - BUCKET, BILGE BAILER or HAND PUMP.** Additional to any electrical or engine driven pump.
 - SPARE PADDLE or AUXILIARY ENGINE or VHF or CELL**
 - TORCH & BATTERIES** preferably waterproof.
 - LIGHTS.** Depends on craft but should have navigation lights and all round white light if under 6M.
 - EXTRA SECURITY ON TRAILER.** Boat secured on trailer in addition to winch. Boat name on trailer recommended
 - DISTRESS FLARES & SMOKE SIGNALS**
